### **Transportation and Distribution Safety Policy**

#### 1. Introduction

PI Industries Limited is engaged in manufacturing agricultural inputs, custom synthesis and manufacturing agrochemicals, fine chemicals, pharmaceutical intermediates, etc. Our operations involve importing & exporting, strong, manufacturing, packaging, transporting, and distributing the products and raw materials including technical support, research, and development.

#### 2. Our Commitment

PI is fully committed to adopting and implementing best practices and engaging reliable logistics partners for handling, storage, transportation, and distribution of its products including raw materials in a safe, secure, and environment-friendly manner. PI has also put in place detailed guidelines and standard operating procedures to govern all business relationships with suppliers, service providers, vendors, traders, agents, consultants, contractors, joint venture partners, and other third parties.

#### In addition, we remain focused to:

- Ensure that all vehicles under Pl's direct or indirect control meet all applicable local, state level or national level laws and regulations.
- Ensure that drivers are trained for proper handling and stowage of the goods being transported and for actions required in an emergency, e.g., fire, leakage or any other hazards Provide safe, secure, and environment-friendly transportation to our employees and products and emphasize our partners to follow industry best practices.
- Ensure that all transport partners/agencies are assessed regularly for their commitments to PI's policies and protocols including but not limited to EHS, Legal compliances, and Supplier Code of Conduct, before their engagement.
- Ensure that vehicles deployed are meeting minimum specifications and inspection criteria before any engagement.
- Encourage and engage drivers for defensive driving through induction training to adopt safe behavior during transportation.
- Ensure that all vehicles maintain minimum safety/security requirements and follow vehicle health checklist regularly.
- Ensure positive communication at all levels to increase transparency.
- Ensure that all transportation-related incidents/accidents are reported and investigated timely to implement effective actions to avoid reoccurrence.
- Ensure that the adoption of any new route should complete Journey Risk Assessment (JRA) through a competent independent agency before deployment.

- Implement a well-defined Emergency Response Plan (ERP) for the transportation of Hazardous Goods.
- Continue efforts to ensure that the transportation system remains safe, secure, and sustainable.
- Inculcate and promote Responsible Care principles in entire supply value chain.
